## EGTON CHURCH OF ENGLAND VOLUNTARY AIDED PRIMARY SCHOOL

#### **ADMISSION POLICY**

### **RELATING TO ACADEMIC YEAR 2015-16**

Egton Church of England Voluntary Aided Primary School is proud to be in the Diocese of York. It is maintained by North Yorkshire Local Education Authority, however, as a Voluntary Aided School the Governing Body is Responsible for Admissions by law.

Our school prides itself on providing a Christian Education and promoting family values within our local community. We help children develop as individuals and fulfil their potential by stimulating learning in a friendly, happy, Christian environment.

## **MAKING AN APPLICATION**

Applications for admission to the school should be made on line at <a href="https://www.northyorks.gov.uk/admissions">www.northyorks.gov.uk/admissions</a> between mid September and the 15<sup>th</sup> January 2015. Egton School also requires additional information not contained on the common application form. This additional information is needed to place your application in the correct priority of admission category. The Additional Information Form is available from the School and should be returned to the school by 15<sup>th</sup> January 2015.

This additional information form is not an application to the school and its return does not guarantee a place at the school, but failure to return it may affect which priority of admission category your application is placed in.

It is not normally possible to change the order of your preferences for schools after the closing date.

Letters informing parents of whether or not their child has been allocated a place will be sent out by the Local Authority by 16<sup>th</sup> April 2015. Parents of children not admitted will be informed of the reason and offered an alternative place by the Authority.

# **ADMISSION PROCEDURES**

The number of places available for admission to the Reception class in the year 2015-2016 will be a maximum of ten. This arrangement follows consultation between the governing body, the Diocesan Board of Education, Local Authorities and other admissions authorities in the area. The governing body will not place any restrictions on admissions to the reception class unless the number of children for whom admission is sought exceeds this number.

The Governing Body operates a system of equal preferences under which they consider all preferences equally and the Governing Body allocates places

according to its policy. In the event that there are more applicants than places, the governing body will allocate places using the following criteria, which are listed in order of priority:

#### OVERSUBSCRIPTION CRITERIA:

- 1. Children with a statement of special educational need naming the school will be allocated a place in line with section 324 of the Education Act 1996.
- 2. Children in Public Care (Looked after Children) and children who were previously looked after but immediately after being looked after became subject to an adoption, residence or special guardianship order.
- 3. Children with special medical or social circumstances affecting the child, where these needs can only be met at this school. Supporting evidence from a professional, eg a doctor, psychologist, social worker, is essential if admission is to be made under the criterion for special medical or social circumstances, and such evidence must set out the particular reasons why our school is question is the most suitable school and the difficulties which would be caused if the child had to attend another school.
- 4. Children whose parents live within the ecclesiastical parish of Middle Esk Moor or civil parish of Egton and Grosmont

  A map showing the boundaries is available in school.
- 5. Children who have a sibling attending the school on the date of application and on the date of admission.
  Siblings include step, half, foster, adopted brothers and sisters living at the same address and full brothers and sisters living apart
- 6. Children with a parent/guardian involved in the life of a church in membership of Churches Together in Britain and Ireland.

  Evidence will be required from your officiating minister. (It should be attendance of at least once a month from Sept13 Sept14).
- 7. Children with a parent/guardian involved in the life of a non-Christian faith in membership of the UK Interfaith Network.

The major world faiths are those in membership of the UK Interfaith Network; in addition to Christians, it includes Buddhists, Baha'is, Hindus, Jains. Jews. Muslims. Sikhs. Zorastrians.

Evidence will be required from your officiating minister. (It should be attendance of at least once a month from Sept 13-Sept14).

### 8. Other children.

Where there are more applicants for the available places within a category, then the applicant living the shortest distance from home to school will be given priority. (All distance measurements are based on the nearest route recognised by the County Council's electronic mapping system from a child's home address to school. The measurement is

made from a fixed point within the dwelling, as identified by Ordnance Survey, to the nearest school entrance using footpaths and roads. The routes measured to determine the allocation of school places will be those recognised by the electronic mapping system used by the school admissions team.)

### **ADMISSIONS INFORMATION**

Last year the school was able to admit all pupils whose parents applied.

### LATE APPLICATIONS FOR ADMISSION

Where there are extenuating circumstances for an application being received after the last date for applications, and it is before the governors have established their list of pupils to be admitted, then it will be considered alongside all the others.

Otherwise, applications which are received after the last date will be considered after all the others, and placed on the waiting list in order according to the criteria.

## **WAITING LIST**

Where we have more applications than places the oversubscription criteria will be used. Children who are not admitted will have their name placed on a waiting list. The names on this waiting list will be in the order resulting from the application of the admissions criteria. Since the date of application cannot be a criterion for the order of names on the waiting list, late applicants for the school will be slotted into the order according to the extent to which they meet the criteria. Thus it is possible that a child who moves into the area later to have a higher priority than one who has been on the waiting list for some time. If a place becomes available within the admission number, the child whose name is at the top of the list will be offered a place. This is not dependent on whether an appeal has been submitted.

This waiting list will operate until the 31st December.

# ADDRESS OF PUPIL

The address used on the school's admission form must be the current one at the time of application. If the address changes subsequently, the parents should notify the school. Where the parents live at different addresses, the current-at-the-time-of-application, normal address of the child will be the one used. This will normally be the one where the child wakes up for the majority of Monday to Friday mornings. Parents may be asked to show evidence of the claim that is being made for the address, e.g. identity cards of various sorts

showing the child's address as the one claimed. Where there is dispute about the correct address to use, the governors reserve the right to make enquiries of any relevant third parties, e.g. the child's GP. For children of UK Service personnel and other Crown Servants returning to the area, proof of the posting is required for us to allocate a place in advance of the family arriving in the area after considering the application against the oversubscription criteria.

## IN YEAR ADMISSIONS

It sometimes happens that a child needs to change school other than at the "normal" time; such admissions are known as in year admissions. Parents wishing their child to attend this school should arrange to visit the school. They will be provided with an application form. If there is a place in the appropriate class, then the governors will arrange for the admission to take place. If there is no place, then the admissions committee will consider the application and information about how to appeal against the refusal will be provided.

Please note that you cannot re-apply for a place at a school within the same school year unless there has been relevant, significant and material change in the family circumstances.

### **APPEALS**

Where the governors are unable to offer a place because the school is over subscribed, parents have the right to appeal to an independent admission appeal panel, set up under the School Standards and Framework Act, 1998, as amended by the Education Act, 2002. For admission into Reception, appeals must be lodged 20 days from the date of notification that the application was unsuccessful. This must be heard within 40 days of the deadline. In year admissions must be heard within 30 school days of the appeal being lodged. Parents will have the opportunity to submit their case to the panel in writing and also to attend in order to present their case. You will normally receive 10 days' notice of the place and time of the hearing.

If your child was refused a place in Reception or Key Stage 1 because of Government limits on Infant class sizes, the grounds on which your appeal could be successful are limited. You would have to show that the decision was one which in the circumstances no reasonable admissions authority would have made, or that your child would have been offered a place if the governors' admissions arrangements had been properly implemented.

Please note that this right of appeal against the governors' decision does not prevent you from making an appeal in respect of any other school.

## FRAUDULENT APPLICATIONS

Where the governing body discovers that a child has been awarded a place as the result of an intentionally misleading application from a parent (for example a false claim to residence in the catchments area or of involvement in a place of worship) which effectively denies a place to a child with a stronger claim, then the governing body may withdraw the offer of the place. The application will be considered afresh and a right of appeal offered if a place is refused.

#### DEFERRED ADMISSION

If your child is due to start school during the next academic year, it is important that you apply for a place for September Although the law does not require children to be admitted to school until the beginning of the term following their fourth birthday, the Governing Body, being the Admission Authority for this school, will admit children into school at the beginning of the academic year in which their fifth birthday falls. We will happily discuss this further, considering the needs of your child.

Parents are able to request that the date their child is admitted to school is deferred until later in the year or until the term in which the child reaches compulsory school age. Parents can request that their child takes up a place part-time until the child reaches compulsory school age. In both instances we would strongly advise discussion with the school.

### **TWINS**

If only one place can be offered then the other twin will also be offered a place as an 'excepted pupil'.
